Pinsa with mortadella and burrata

Raw material:

70 g Gouda, grated
100 g Burrata buffalo mozzarella
100 g Mortadella with pistacchios
250 g Pinsa

Spices & processing aids:

30 g Pesto Crema für Pinsa
20 g Pistazien enthäutet iranisch

Processing sequence:

Spread the pesto on the pinsa, top with cheese and mortadella.

Bake in the oven at 200 °C for about 7 minutes.

After baking, sprinkle with pistachios and then place the whole burrata on top of the pinsa.

Ingredients:

Pinsa (WHEAT FLOUR, water, HARTWEIZENGRIEß Sauerteig (water, WHEAT FLOUR), extra virgin olive oil, salt, yeast, GERSTENMALZMEHL, Alkohol. Das Produkt kann Spuren von SENF und SOJA enthalten), Burata (Büffelmilch 85%, Kuhsahneerzeugnis (ultrahocherhitzt) 15%, salt, rennet), Mortadella mit Pistazien (72% pork meat, Speck, water, 3% PISTACHIO, salt, spices (mit SENF), dextrose, potassium iodate, hydrolysed vegetable protein, Aromen, antioxidant (ascorbic acid), colouring agent (Cochenille), flavour enhancer (Natriumglutamat), preservative (sodium nitrite), acid (citric acid), stabilizer (Diphosphat, sodium lactate)), Gouda (MILK, salt, Säuerungskulturen, rennet, preservative: E 250 sodium nitrate, colouring agents: Annatto, Carotin, potato starch), PISTACHIO, water, vegetable (cherry tomatoes, garlic), rapeseed oil, herbs, parmesan (MILK, salt, rennet, preservative: E 1105 LYSOZYME), extra virgin olive oil, pine nut, salt, wine vinegar, spinach powder, tomato flakes, MILK PROTEIN, modified starch, LACTOSE, preservative: (E 211 sodium benzoate, E 202 potassium sorbate), spices
